#### WHY IS LIBERTY FOCUSING ON THE ENVIRONMENT?

People of color have environmental experiences that differ from those of whites because the environment, like race, is both a social and a cultural construct. Throughout history, those whom society has identified as white have appropriated land and resources, controlling the movement and hindering the economic development for people of color. Environmental racism harms communities of color. It is just as real as the racism that exists in housing, employment, and education.

Environmental racism is racial discrimination in environmental policymaking. It is racial discrimination in the enforcement of regulations and laws. It is racial discrimination in the deliberate targeting of communities of color for toxic waste disposal and the siting of polluting industries. It is racial discrimination in the official sanctioning of the life-threatening presence of poisons and pollutants in communities of color. And it is racial discrimination in the history of excluding people of color from the mainstream environmental groups, decision-making boards, commissions, and regulatory bodies.

The Gathering has created space and time to discern individual and collective calls to action, to heal the planet, and heal ourselves. WHAT IS YOUR CALLING?
